## 2. Notes on Elements

This document contains all the validation rules, which must be passed to enable a successful upload onto ROS for the New Employee Forms P45 (3) and P46.

These include for each attribute or element:

- Correct data formats
- Maximum and minimum values where applicable
- Dependent attributes or elements other elements that must not be null or other attributes for which values must be returned in certain circumstances.

All completed files must have the .p453 extension in the filename to upload successfully into ROS.

The file will consist of a root P45P3File element.

#### 2.1 P45P3File

The P45P3File element has the following attributes:

currency	E, required	E for Euro	
product	Alpha, required	Third party software product identifier.	
formversion	Numeric, required	Must be equal to '1' for this version of the file format. Will change with each new edition of the form.	
language	E or G, required	E for English, G for Irish	

It then consists of one Employer element and one or more P45P3 elements.

#### 2.2 Employer

The Employer element has the following attributes:

name	Alpha, required	Name of Employer, up to 30 chars	
tradename	Alpha, optional	Trade name of employer, up to 30 chars

address3	Alpha, optional	Address field 3, up to 30 chars	
contact	Alpha, optional	Employer contact name, up to 20 chars

#### 2.3 P45P3

At least one instance of the P45P3 element is required and it has one attribute:

It consists of the following sub-elements – Employee, NewEmployment, and PrevEmployment.

#### 2.4 Employee

Employee is a required element on P45P3.

It consists of the following attributes:

ppsn	Alpha, required	The registration of the employee (7 numeric chars and 1 alphanumeric. Supports additional alphanumeric W, X or T). Must be valid PPS number.
surname	Alpha, required	Employee Surname, up to 20 chars.
firstName	Alpha, required	Employee first names, up to 20 chars.
addressline1	Alpha, optional	If formtype="P46" then this is a required address line, up to 35 chars. If formtype="P45P3" then this attribute should not have a value.
addressline2	Alpha, optional	If formtype="P46" then this is a required address line, up to 35 chars. If formtype="P45P3" then this attribute should not have a value.
addressline3	Alpha, optional	If formtype="P46" then this is an optional address line, up to 35 chars. If formtype="P45P3" then this attribute should not have a value.
addressline4	Alpha, optional	If formtype="P46" then this is an optional address line, up to 35 chars. If formtype="P45P3" then this attribute should not have a value.

#### 2.5 NewEmployment

The NewEmployment element consists of the following attributes:

datecommence ment	Date, required	Employment start date, (DD/MM/YYYY)
unit	Alpha, optional	Works/Payroll number, up to 12 chars.
freq	W or M, optional	Frequency of payment, either weekly "W" or monthly "M".

#### 2.6 PrevEmployment

The PrevEmployment element is a required element if the formtype="P45P3". If the formtype="P46" then this element should not exist. The PrevEmployment element consists of the following attributes:

datecessation	Date, required	Employment end date, (DD/MM/YYY)
